Respondent's attorney appeared in court on June 22, 2021. Additionally, respondent is now fully aware of the temporary GVRO filed against him, and his guns have been seized by CVPD officers.

I am requesting that your honor unseal – on the court's motion – the following court records:

- 2) <u>Unredacted</u> versions of the California Law Enforcement Telecommunications System Information Form (CLETS-001), the Civil Case Cover Sheet (CM-010), the Petition for Firearms Restraining Order (GV-100), the Declaration and Attachments (MC-030, MC-031), the Notice of Court Hearing (GV-109), the Temporary Firearms Restraining Order (GV-110), the Firearms Restraining Order After Hearing (GV-130), and the Declaration of Counsel supporting the application.
- 3) ROA #13 Motion-Other. This item was the subject of an APPLICATION AND ORDER CORRECTING COURT RECORD on May 7. ROA #13 does not, however, appear on the online ROA.
