Description: **I am preparing to air a report on the death of John Fitzpatrick and missing person Fang Jin. I had a few questions regarding Fitzpatrick, since his remains were found in SAN DIEGO jurisdiction:**

What was the date, time and location Fitzpatrick's truck was found in Anza Borrego? Was the truck stuck in the sand or disabled?

What was the date, time and location his body was found "nearby"? How far away from the truck?

Can you please confirm reports from Jin's family that Fitzpatrick's cell phone last pinged in Julian on July 27?

In addition to the questions below, regarding the discovery of John Fitzpatrick's truck and remains, I am requesting the following information as required by the California Public Records Act:

"...the time, substance, and location of all complaints or requests for assistance received by the agency and the time and nature of the response thereto, including, to the extent the information regarding crimes alleged or committed or any other incident investigated is recorded, the time, date, and location of occurrence, the time and date of the report, the name and age of the victim, the factual circumstances surrounding the crime or incident, and a general description of any injuries, property, or weapons involved."
