PROBABLE CAUSE:

On February 10, 2023 an undercover operation targeting subjects soliciting prostitution online was conducted by the Polk County Sheriff's Office within Polk County, FL. During the operation, female and male detectives worked in an undercover capacity, posing as escorts and customers "johns". Female detectives posted fictitious advertisements online posing as escorts and male detectives replied to advertisements for subjects offering escort services. All arrests that occurred inside the undercover location were audio and video recorded.

[redacted] (undercover deputy) was working in an undercover capacity and posted an escort advertisement online. [redacted] was contacted by and communicated with a subject later identified as Scott Wooden (defendant). During text message/phone conversations, the defendant agree to come to the undercover location for either \$50.00 for oral sex, \$150.00 for oral and vaginal sex with a condom, or \$200.00 for oral and vaginal sex without a condom. The defendant found the undercover deputy's ad on "Mega Personal" and communicated through the phone number 410-999-0102.

At approximately 1658 hours, the defendant arrived at the undercover location where the undercover detective made contact. The defendant told the detective he wanted to have oral and vaginal sex without a condom and paid her \$200.00 in cash. The defendant was taken into custody without incident.

At approximately 1714 hours, I conducted a recorded post-Miranda interview with the defendant. He advised he responded to an ad on a website he could not remember the name of and "got caught doing something stupid". He advised he was told where to go and arrived to the undercover location where he was then arrested. When asked what was talked about inside, he advised he did not wish to answer any more questions.

The defendant is a retired Biotechnology Scientist (pharmaceuticals), a member of the Delmar Union Schools School Board member, and is married with children.

The defendant was arrested for soliciting another to commit prostitution and was transported to the Sheriff's Processing Center without incident.
