Larry has not suspended communication with the maternal side of the family. In fact, even though May was missing, May's side of the family came to Larry's house and had a party on January 10, 2021. Again, on January 17, 2021, Maya's family came over. The maternal side

of the family did not communicate with us, not even offer to buy food for the children, or ask us if the kids need anything until now.

We have taken residency with our son to help raise our grandchildren since 2010. My wife and I have been there for all three grandchildren since birth up to the present time. My wife prepares them four or more meals a day. I help by driving them to school and all their afterschool activities and some medical appointments.

The maternal grandparents, Pablito and Naomi Tabalanza, filed a petition in May 2021 seeking visitation with the grandchildren. Larry objected to the visitation because of Maricris and Richard's drunkenness, child neglect, and contaminating the family home with second-hand smoke, and the maternal grandparents' inability to communicate effectively in English, further, there are no bedrooms for our grandchildren to sleep at their house in Moreno Valley.

The grandchildren have been cared for, fed and loved by me and my wife Judith. We are the main caregivers while our son Larry and his wife are at work. We are happy and delighted that we can share life with them. My wife and I are seeking guardianship of our grandchildren:

The maternal side of the family, including Maricris Drouaillet have not played an integral part of the children's lives since birth. They live over an hour away in Moreno Valley and in Los Angeles; and would only see them on some major holiday celebrations and birthdays. They did not come down to our residence to see the children at all. The maternal side of the family did not even give gifts or presents to the three grandchildren during birthdays and Christmases.

Our grandchildren are safe, secured, happy, and healthy living with us in their home,
despite the situations in regards to their missing mother and their father who is in custody. Why
disrupt this stability that the children have? They live in a nice clean home, are well fed and have

their own rooms; something their maternal side of the family could not provide for them. They are enrolled in a decent and reputable school; excelling in their classes and have close friends that support them through these difficult times. They are busy with school activities and after school activities, playing with their friends. Martial Arts, Taekwondo, Jiu- Jitsu, kick boxing. They also have after school tutors and used to attend ballet. They have a busy week schedule and weekend schedule for their tournaments and after school activities.

Petitioner Maricris and her husband have made public statements to consistently defame our son Larry, the children's father, on social and news media - creating a toxic environment for the children. They have published pictures of the grandchildren without permission from their parents to multiple social and news media, creating a safety issue for minors.

Last Sunday, November 14, 2021, Maricris picked up the grandchildren from our place and they used a car that contained a large poster of their missing mother May. The grandchildren, specially was upset when he saw his mother's picture posted on the car. Maricris was also not ready with a car seat for to use, so we allowed her to borrow our car seat.

We will continue to provide care, stability, love and support to our grandchildren and we respectfully request that the court will grant our petition for permanent guardianship.

Since then, May was in our house almost everyday, eating our food and sleeping in the house. May's parents and family were not looking for her, nor called her even once. While residing with us, May had a serious vaginal bleeding and we rushed her to the hospital. She had a spontaneous abortion before she married Larry. May did not have any medical insurance so my son Joel paid for her hospital bills. After her discharge from the hospital, we brought her home and took care of her, fed her, until she married our son Larry.

Later, we helped Larry and May to pay for their rent when they moved to San Diego. Again, when they needed our help in buying a house in San Diego, Benito bought the house under his own name because May and Larry would not qualify for the loan. And since about 2020, Benito was bringing up food upstairs so that May could eat everyday, because May refused to go downstairs to eat with the children and the rest of the family until the day she left the house without saying goodbye to anybody.
