Hello Atty Martinez,

My name is Alice Famador; we are the immediate next door neighbor of the Millette family. With the many years that we were neighbors, I am bothered that Maricris is asking for guardianship for the kids of Larry and Maya. The kids are safely cared in their Chula vista home so why change the daily routines of these children and make their life miserable and move them into a place that is against the children's will.

I've lived in Paseo Los Gatos since 2003. When Larry, Maya and their children moved to this community after few years , the parents of Larry were both with them. When we meet them all for the first time, we saw them as family oriented, good people, loving and have close family relationship. The children, so young at that time were so close to the grandparents, Larry's parents.

The grandparents, helped Larry and Maya take care of the 3 children especially when they both are at work during the daytime. They, the grandparents, watch the children while playing at the backyard. The grandparents, Larry's parents were so loving to the children and the 3 children love them so much. They gave their grandparents big respect. These three kids grew up with their grandparents since the eldest was a baby. We seldom see maricris come in the neighborhood and visit these children. I understand they spend SOME weekends at Moreno valley, but that is not even equal or close enough to the amount of time spent by these children in their own home with their parents and grandparents. We have hosted many parties in our homes, and this whole family is always there, so we know the closeness they have. We know the attachment these children have to their grandparents. It is NOT the best idea at all for maricris to just take these children away from the people who these children sees all the time the moment they open their eyes in the morning . Even when these kids go to school before covid pandemic days, it is the father of Larry that drops off the kids and picks them up to school. He walks these children to the park, and watches them play their bikes there. When all these things that have happened, the parents of Larry continued to fill the role of "parents" to these children making sure the kids does not miss their school and activities. Just like today, the kids want to eat Mc Donald's food, so the grandpa drove the kids for their happy meals. It's what makes the children happy.

The love and concern of the grandparents, Larry's parents were beyond measure. And the 3 children, so young at their age, cherish that love for them so much day by day in their lives. The 3 children grew up with the presence of the grandparents in their home. As they wake up every day, they have that special attachment, closeness, and love to their grandparents.

With the present situation, the grandparents, Larry's parents takes these children to school, pick them up after school and take care of them at home with the absence of Larry and Maya. They draw love and support from their grandparents and they, the 3 children don't want to be separated from their grandparents, Larry's parents.

In one of Maya's Facebook post – she even captioned one picture she posted “ Coming home late from work to this awesomeness! They have such amazing grandparents”. Then shows a photo of the Larry's father watching the child playing bike in front of their house.

Looking at the children, they were so comfortable, happy and feel so loved and feel safe with the grandparents, Larry's parents. Until today, we see these kids, we talk to these kids, and what we see in these children is the exact opposite of what the public describes them.

Thus, I do have a concern for the children if they are moved from their home where they lived for years, being separated from their grandparents whom they loved and lived with for over 11 years or more, and whom they loved and respected as their 2nd parents.


Currently, the children attend school near their home, about 5 minutes away. They were loved by everyone in the school, the teachers, their friends, classmates who gave them every day moral support to help them cope with the situation they are in. Liberty elementary school is very supportive to these children. Why take them away from this school they are already currently attending.

The 3 children grew up in this community whom they feel being loved by the neighbors.

Putting them in another home environment with new people, new house room but will no longer have a solo room as they are living now, new community, new school environment, new teachers, new classmates, new friends. All of these will bring traumatic experience to the lives of the 3 children.

I'm just praying for the best for the 3 children so they will grow happy children, emotionally stable, grow physically, spiritually, safe and healthy and be with the people who have taught them how to learn and love. Please help fight for these children to stay where they are currently, and where they have a home big enough for them to move around and have their own room.
